Professional Development and Training: Janet—The \$25K check arrived from Praxir to cover Part 1 and 2 of the initial PD&T plan. Part 1 was the hosting of the 2 Praxair scientists in Dallas, as previously reported, and this will be repeated in Boston (close to Praxair). Part 2 will include training for 30-40 women chemists and chemical engineers in July 2014 at Praxair in Buffalo. The plan is that this one day workshop to be a model that BMGT can use at other venues in the future. Janet, as the project manager of all this work, is working offline with Nick regarding the expenditures and any tax implications.

Networking: Mick will submit minutes from this group's meeting in Dallas. A YCC'er is interested in helping BMGT with social media. POLY AIB and Mick met in Denver to co-sponsor events in San Fran, and to co-plan in Denver & Boston.

Advocacy: update re: CIEC from Janet: Dave Harwell (ACS HQ) reported that ACS is presenting a bsns plan/pitch review program in San Fran and wanted BMGT input (Sun – Tues in San Fran). Then there will be an investor mtg (for pitches) on the Wed PM in San Fran. Need a champion for San Fran: Dan suggested Sharon to connect the mentors and mentees on Sunday.

Organizational Strength: Nick—discussion with large consulting firms (Boone and McKinsey)—projects and trends in the chemical and pharmaceutical industry? Recruiting tool for other ACS members—jobs in the consulting industry? (Note—SCHB division already has a high focus on the consulting industry, so would be a natural partner for this.)

- <u>Treasurer Update</u>–Nick update as of 5/17/14: Total funds: \$102,489.43. Restricted funds from prior MM2 event: \$17,532.36. Unrestricted funds: \$84,957.07—this includes the \$25K from Praxair which is also restricted in 2 buckets: 8K(now 7.6 due to \$400 of cost in Dallas) and 17K. ACS Dallas meeting costs—for meeting rooms are still outstanding.
- Update on CIEC Janet above in Advocacy Team and this: CIEC is compiling the meeting roadmap for San Fran. Interest from MAC and YCC for info re: CIEC monthly meetings.
- Industrial Chemist Award Dan led the discussion: it is thought that there is a 3-year deal to split the cost 50/50 with the I&EC Division. BASF and 3M were not interested in helping with this Award. Mick will plan a face-to-face meeting in San Fran to swap the Industrial Chemist Award with the Barnes Bsns Mgmt Award. Mick will send out a Doodle poll for BMGT folks and will learn Staff/Felicia's availability. Dan will let know Felicia that BMGT will fund this (\$5K) for 2014.
- Angela solicited input for the monthly BMGT newsletter—this is sent out at the end of most months.
